- TV: Logo and tagline clearly and prominently shown, plus audible mention of both brand and tagline
- Radio: Audible mention of brand 2x in a 30-sec / 3x in a 60-sec spot; tagline ("turn to the experts") 1x per spot
- Print: Carrier logo should be EQUAL in size to the dealer logo
